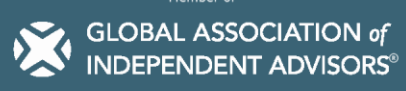

## **PRIVACY POLICY**

This Policy was last updated on 5<sup>th</sup> October 2021.

Alman Partners Pty Ltd ACN: 090 789 218 ('**we**', '**our**', '**us**') is bound by the Australian Privacy Principles (**APPs**) contained in the *Privacy Act 1988 (Cth)* (**Privacy Act**). This Privacy Policy (**Policy**) sets out how we collect, use and share your personal information and how to contact us with any queries or concerns.

By voluntarily supplying us with your personal or credit information, you are agreeing to be bound by this Policy. While we may update our Policy from time to time, the most recent version of this Policy will always be available on our website. If we change the Policy in any material way we will post a notice on our website along with the updated Policy. We may also contact you via your contact information on file, for example by email, notification or some other equivalent measure.

### **Collection of personal information**

We normally collect personal information directly from you but if you have consented, we may also collect personal information from a third party. The type of information we hold varies depending on the type of product or service we provide to you. For example, Alman Partners will hold different information about you if we develop a comprehensive financial plan than we will hold if we are recommending life insurance products.

The personal information we may collect and hold about you includes:

- contact information such as your name, address, telephone numbers and email address;
- identification information such as your driver's licence;
- financial information, including bank account details and credit card details;
- business details, including Australian Business Number ("ABN");
- occupation, your employer's name and address, your salary;
- the names and addresses of your dependants or beneficiaries;
- tax file number, where you have given it to us;
- health information (for insurance purposes);
- insurance claim information, where this is relevant;
- other information that you have given us.

## **Means of collection of personal information**

Your personal information may be collected in a number of ways, including:

- directly by our staff when you seek, or enquire about our services;
- via telephone or email;
- via our Personal Financial Profile (data collection document);
- via Application forms; or
- when you use our website or complete a form on our website.

In some circumstances, where it is unreasonable or impracticable to collect information from you, we may collect information about you from a third-party source. For example, we may collect information from a publicly maintained record or from relevant fund or service providers. You need not provide all the information requested by us, but this may prevent us from providing some or all of our goods or services to you.

## **Use, disclosure & purpose**

We collect, hold and disclose your personal information for the purposes related to the provision of financial services including:

- Preparation of your financial plan;
- Provision of financial planning advice to you;
- To verify identity and for customer due diligence purposes;
- Making securities and investment recommendations; or
- Reviewing your financial plan, securities and investment recommendations; and
- All purposes related to any of the above listed purposes.

We will only use your information for the purposes for which it was collected ("primary purposes") or a purpose related to the primary purpose, if this use would be reasonably expected by you, or otherwise, with your consent.

Alman Partners Pty Ltd will only disclose your personal information for a purpose related to the services you are procuring from us. Information provided to third parties will be dealt with in accordance with that entity's privacy policy. Information provided will be held in the strictest confidence by us. We do not give information about you to anyone else unless one of the following applies:

- It is necessary in order to provide you with the financial services you expect us to, or we have told you we will;

- You have consented; or
- It is required or authorised by law.

How we use the information we collect depends, in part, on which services you use, how you use them and any preferences you have communicated to us. If you would like to restrict how your personal information is handled beyond what is outlined in this Policy, please contact our Privacy Officer.

Where we use an external third party in the course of providing our services to you, we will provide your personal information to that external service provider for the exclusive purpose of assisting us to provide services to you. We use external service providers to assist us in providing advice. We will also disclose your personal information where such disclosure is required by law.

We disclose your personal information to third parties that:

- Manage and enhance our customer database including Enzumo.
- Send marketing information to you on our behalf including MailChimp, Strategic Media Partners; and
- Other purposes related to the above.

We do not sell or license your information to third parties.

If you do not consent to such disclosure, we will not be able to provide you with financial services. The types of organizations to whom we typically disclose your personal information include administration services, information technology staff (for the purpose of maintenance of our IT systems) and related service providers, superannuation trustees, product issuers including insurance companies as well organizations undertaking compliance reviews of our representatives or other due diligence undertaken on us or our representatives. If we transfer personal information outside Australia, we comply with trans-border data flow privacy standards under the Privacy Act, for example, by taking reasonable steps to protect the information being held, used or disclosed by the recipient pursuant to the Australian Privacy Principles.

Should you wish to authorise the disclosure of your personal information to other parties, please notify us in writing. We may use personal information collected from you to advise you about other financial products and services or survey your opinions on

products or services. You may elect not to receive such information by contacting your representative or writing to the company's Privacy Officer, in which case, we will record that you do not want to receive marketing material.

If you choose to not provide identity information and personal information, or information that is incomplete or inaccurate, it may:

- Mean that we cannot provide you with financial services;
- Result in you paying more tax than may otherwise apply;
- Result in the provision of a financial service that is not appropriate to your circumstances, needs and objectives.

Alman Partners may collect client personal information when purchasing other financial advisory businesses.

### **Quality, access to & correction of information**

You are entitled to have access to and seek correction of any personal information that we may hold about you. We require that requests for access to or to update or correct your personal information to be in writing outlining the details of your request. Such requests should be addressed to the Privacy Officer via the details provided in this Policy.

We will take appropriate steps to verify your identity (or verify that you act as an authorised agent of the individual concerned) before granting a request to access your personal information.

We will respond to your request for access to your personal information within a reasonable time after you make the request and if access is granted, access will be provided within 30 days from your request. We will, on request, provide you with access to your personal information or update or correct your personal information, unless we are lawfully excluded from granting your request, including if:

- giving access would be unlawful;
- we are required or authorised by law or a court/tribunal order to deny access; or
- giving access is likely to prejudice one or more enforcement related activities conducted by an enforcement body.

Where your request for access is accepted, we will provide you with access to your personal information in a manner, as requested by you, providing it is reasonable to do so.

Your request for correction will be dealt with within 30 days, or such longer period as agreed by you. If we deny your request, we will provide you with a written notice detailing reasons for the refusal and the process for making a complaint about the refusal to grant your request.

### **Storage and Security**

Your personal information will be stored as physical files in a secured area, on our electronic data base system and on computers with appropriate back up and security systems. Any personal information which is collected via our website, or which is held on our computer systems, is protected by safeguards including physical, technical (including firewalls and SSL encryption) and procedural methods.

We take reasonable steps to hold information securely in electronic or physical form. We are committed to keeping secure the data you provide to us and we will take all reasonable precautions to protect your personally identifiable information from loss, misuse, interference, unauthorised access or alteration.

We aim to achieve this through:

- putting in place physical, electronic and procedural safeguards in line with industry standards;
- imposing confidentiality requirements on our employees and outsourced providers, requiring any third party providers have acceptable security measures to keep personal information secure;
- implementing policies in relation to document storage security;
- implementing security measures to govern access to our systems;
- only providing access to personal information once proper identification has been given;
- controlling access to our premises;
- implementing website protection measures; and

- When we store your data we use Advanced Encryption Standard (AES) with 256-bit keys. If we need to transmit your data it will be via secure portals and/or password protected.

While we take all steps reasonable in the circumstances to protect your information, in the unlikely event a data breach occurs, we will notify you in accordance with our obligations under the Privacy Act.

If we no longer require your personal information, and are not legally required to retain it, we will take reasonable steps to destroy or de-identify the personal information.

### **Dealing with us anonymously**

Where lawful and practicable to do so, you can deal with us anonymously or using a pseudonym. You can deal with us anonymously or using a pseudonym when making a general enquiry about the goods and services that we can offer to you including via telephone or our website.

At the time you purchase our goods or engage our services, it is no longer practicable for you to deal with us anonymously or using a pseudonym as we will not be able to provide services to you without this information.

### **Complaints**

If you are concerned that we have not complied with your legal rights or the applicable privacy laws, contact our Privacy Officer in the first instance. Please contact our Privacy Officer with a thorough description of your concerns and a response will be provided within a reasonable period (no longer than 7 days). All complaints must be in writing.

When processing a complaint, we will require you to provide us with information to confirm your identity before processing a request related to information we may hold about you.

We expect our procedures will deal fairly and promptly with your complaint. However, if you remain dissatisfied, you can also contact the Office of the Australian Information Commissioner as follows:

## **Google AdWords**
